The USS Colahan (DD-658), a Fletcher-class destroyer built during World War II, fought her way across the Western Pacific in 1944-45, winning eight battle stars in the face of the Imperial Japanese Navy. Her Pacific War story was told in *The Original Tomcat*, published in four limited editions in 1994-97. Here is the sequel, in which the Colahan gains five more battle stars off Korea and serves staunchly in the Cold War before settling, at the end, into a watery grave.

Courtesy of Herb Messinger of Starrucca, Pennsylvania, who served aboard the *USS Colahan* in the early Fifties. The destroyer is shown coming into San Diego Harbor no earlier than the fall of 1952. In the summer of that year, the *Colahan* received her tripod mast in a shipyard overhaul. She had carried a flagpole mast during her Pacific War service, 1943-45, and also during her first Korean War tour, 1951-52. The "Tomcat" was now "Old Tom." She would look like this for the rest of her life.
